1. This Invitation for Tenders follows the General Procurement Notice for this Project which appeared in **Daily News ISSN 0856-3812** dated **13th October, 2016**
2. The **Msalala District Council** received fund from the **ACACIA** towards the cost of **Proposed Construction of Bugarama Health Centre Phase II** and it intends to apply part of the proceeds of this **fund** to cover eligible payments under the contract **for Proposed Construction of Bugarama Health Centre Phase II in Msalala District Council.**
3. The **Msalala District Council** now invites sealed Tenders from **eligible and qualified Building Works Contractors** registered in **Class III and above** for carrying out the **Proposed Construction of Bugarama Health Centre Phase II .**
4. Tendering will be conducted through the **National Competitive Bidding (NCB)** specified in the Procurement Regulations, 2013 – Government Notice No.446 and is open to all Tenderers as defined in the Regulations unless otherwise stated in the Tender Data Sheet.
5. Interested eligible Tenderers may obtain further information from and inspect the Tendering Documents at the office of the **Secretary of the Tender Board, Msalala District Council, and P.O.BOX 16, Kahama, Tanzania.** From **08:30hrs to 15:30hrs** on **Mondays to Fridays** inclusive except on public holidays.

6. A complete set of Tendering Document(s) in **English** and additional sets may be purchased by interested Tenderers **on the submission of a written application** to the address given under paragraph 5 above and upon payment of a non-refundable fee of **Tshs 200,000** (Tanzanian Shilling Two Hundred Thousand Only). Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to the **District Executive Director, Msalala District Council, P.O.BOX 16, Kahama**
7. All Tenders must be accompanied by a Tender securing in the format provided in the Tendering documents unless otherwise stated in the Tender Data Sheet.

All Tenders in **one original plus three copies**, properly filled in, and enclosed in plain envelopes must be delivered to the address **Secretary of the Tender Board, Msalala District Council, P.O.BOX 16, Kahama, on or before 10:00hrs Thursday 16th February, 2017**. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at the **Msalala District Council, Head Office**.
9. Late Tenders, portion of Tenders, electronic Tenders, Tenders not received, Tenders not opened at the Tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
